**WHEREAS**, the Holder is now coming forward in good faith to comply with the Abandoned or Unclaimed Property Law, and

**WHEREAS**, the State desires to induce the Holder's compliance with the Abandoned or Unclaimed Property Law.

**NOW THEREFORE**, in consideration of the mutual promises hereinafter set forth, the parties agree as follows:

The Holder has reviewed the provisions of 12 <u>Del. C.</u> § 1173, and by signing this VDA-1 enrollment form, attests to the fact that the Holder, including all subsidiaries and/or related entities who intend to participate as detailed below, is eligible to enter into an unclaimed property voluntary self-disclosure agreement pursuant to 12 <u>Del. C.</u> § 1173(e). Should the Holder, or any subsidiary and/or related entity participating, be deemed ineligible pursuant to Section 1173(e) or any other provision of Delaware law, then this Form VDA-1 enrollment shall be deemed null and void only with respect to those entities which are deemed ineligible to participate.

The Holder shall complete a review of its books and records and file reports for all abandoned property related to all transaction years beginning January 1, 2005 (i.e., property presumed abandoned pursuant to the Abandoned or Unclaimed Property Law) to the present. Holder's review shall be completed in a manner which is consistent with the "Department of State Abandoned or Unclaimed Property Voluntary Disclosure Agreement Program Regulations Relating to Estimation," the "Secretary of State's Implementing Guidelines Abandoned or Unclaimed Property Voluntary Disclosure Agreement Program" and the associated deliverables as outlined in these documents.

The State agrees that, upon its satisfactory review and approval of the reports and materials submitted by the Holder, and upon payment of the abandoned property to the State or the establishment of a payment plan by the Holder that is accepted by the State, the State will enter into its form Voluntary Self Disclosure Agreement with the Holder, granting the Holder the protections contemplated by that agreement.

The Holder agrees to enter into a Voluntary Self Disclosure Agreement with the State and to either pay the abandoned or unclaimed property due to the State under the Abandoned or Unclaimed Property Law, or enter into a plan for its payment, no later than the two year anniversary of the effective date of this Agreement. If the Holder fails to enter into a Voluntary Self Disclosure Agreement and make payment or enter into a plan for payment within 30 days after the two years have expired, may be referred to the State Escheator for examination

pursuant to Section 1172 of Title 12 of the Delaware Code. However, the Holder and State shall work together in good faith to complete the Program as soon as practicable.

The Holder understands that time is of the essence and the Holder's delay in completing its review may result in either

- (i) removal of the Holder from the program, or
- (ii) the imposition of interest on the abandoned property payable to the State, notwithstanding the parties' expectation that by the terms of the form Voluntary Self Disclosure Agreement to be executed after the Holder's review of its books and records that interest is to be waived. In the event of such delay, the form Voluntary Self Disclosure Agreement will be amended to provide for the imposition of interest on all abandoned property payable to the State from the due date of the report(s).
